

Who to contact for mesothelioma claims.

The following dedicated contact facilities are provided to help speed up the mesothelioma claim process. Using them for other purposes is counterproductive.

You should only use the following contact details:

- To notify an insurer of a new mesothelioma claim specifically concerning them
- For correspondence with an insurer regarding an ongoing mesothelioma claim specifically concerning them

You should not use them:

- For general enquiries regarding a mesothelioma claim
- For any other disease enquiries
- To check progress on a Tracing Code enquiry you have submitted. Your enquiry is being processed by an automated system, and other organisations cannot comment until you have received the results of your enquiry.
